基本入會資格 Eligibility

1. 凡從事會議展覽及相關行業的團體，認同本會宗旨並願意遵守本會會章者
 Any applicant (i.e. company or organization) belonging to the MICE or related industry and agrees to comply with the rules & regulations of MCEA.
2. 申請者的公司應至少在澳門成立兩年或以上
 The applicant's company should have been established for at least two years in Macao.
3. 由兩位常務理事推薦入會
 The applicant should be recommended by two Standing Committee Members of MCEA.
4. 海外申請人的公司應與會展行業相關，並在澳門成立至少兩年。特殊例子可由常務理事會特別批核
 Overseas applicants business should be related with the MICE industry and is established in Macao for at least two years. Particular case can be considered by the MCEA Standing Committee Meeting on a case by case basis.
5. 收回表格後須經審議，協會秘書處審核申請者資料後上呈常務理事審批
 Upon submission of application, secretariat will verify the applicant's background prior to the approval by the MCEA Standing Committee Meeting.

 MCEA reserves the final decision right.
